\*If you have arrived in Sweden in the past 6 months, you must provide a police check from your home country as well as a Swedish police check.

## **Emergency Procedures while on school premises:**

All activities leaders are responsible for the children in their care during the activity time.

### **Evacuation**

Locate the fire exit plan located in each room near the door. In case of evacuation due to an alarm, accompany the children to a meeting point outside the school. Make sure the room is empty and close the door. Call emergency services number: 112.

### Injury

Move children away from the injured person and any dangerous objects or materials. Call emergency services number: 112 if necessary. Call the child's parents. Locate the first aid station and the heart defibrillator in the campus staff room.

### Nuts

All foods containing or having contact with nuts or sesame seeds are strictly forbidden on school property.
